



Job Description – Maintenance Diver (Part-Time)

Job Summary:

The Maintenance Diver position will work closely with the Exhibits department to provide daily animal exhibit maintenance support. This role requires quick hands-on learning for a wide variety of tasks related to the upkeep and safety of animal exhibits at Coral World.

This position requires a hard-working, trustworthy, and reliable candidate with strong communication skills.

The position will be managed by the Assistant Curator of Exhibits, however, may respond to other department heads as needed.

Duties/Responsibilities (Essential Functions):

- Performs daily/nightly cleaning and maintenance tasks in saltwater exhibits and habitats
- Operate typical aquarium equipment such as siphons hose and tubes, scrapers, scrub poles, and associated SCUBA equipment
- Operate pneumatic, hand and power tools
- Operate gas/electric engine and pumps
- Tasks may be indoor, outdoor, or in/under water
- Shows respect for animals and is observant of their behavior related to the work being performed. Communicates all pertinent observations quickly to managers.
- Use best judgement to ensure staff and animal safety and well-being at all times as a number one priority.
- Animal care and training tasks may be assigned depending on experience level, time spent in the area and demonstration of strong communication and teamwork skills.
- Candidate should be clear in communicating their level of training.

Supervisory Responsibilities:

This position has no supervisory responsibilities.

Work Environment:

This job operates in a professional environment (indoor and outdoor). The employee will be exposed to sunny, warm, humid, and wet conditions. This role routinely uses more advanced tools such as drills, power cleaning equipment and air compressors.

Physical demands:

The physical demands described here are representative of those that must be met by the employee to successfully perform the essential functions of this position. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions. This position requires the employee to stand, swim, and lift for most of his or her working hours but occasionally must stoop, kneel, crouch, or climb. The Maintenance Diver must frequently lift and/or move up to 75 pounds. Specific vision abilities required by this job include close vision, distance vision, color vision, peripheral vision, depth perception and ability to adjust focus.

Position Type and Expected Hours of Work:

This is a full time, 40 hours/week position with opportunities for overtime. Days are scheduled around a 7-day work week. During the slow season hours and days may be reduced to accommodate the needs of the company.

Eligibility Requirements:***Required:***

- Minimum 18 years of age.
- High School Diploma or equivalent
- SCUBA certification from a known organization
- Ability to lift up to 75 pounds and to pass a dive physical
- Basic understanding and comfortable handling power and hand-held tools, engines and pumps
- Comfortable with exposure to noise, vibrations, and harsh conditions
- Ability to train and properly use protective gear
- Passion for cleanliness, organization, and quality standards
- Ability to meet federal, state and local requirements for employment.
- Ability to stand for long periods of time and walk long distances within the location.
- Must be professional, dependable, reliable, and have a strong work ethic
- Desire to work around animals and guests
